

Creating a safe, health-conscious community.

To ensure the safety of our clients, First Legal has verified that each of our off-site conference room locations have implemented and are adhering to CDC COVID-19 related recommendations.

Dots Space is committed to the following:

Member Safety

All members and staff undergo daily temperature and symptom checks. If anyone is experiencing any symptoms such as fever, cough, difficulty breathing, or other COVID-19 symptoms, they are not allowed entry.

Wearing face masks or face coverings is mandatory at all times in open spaces such as communal spaces, kitchens, hallways, lobbies, inside and around the spaces. Face masks are provided to members, their guests, and anyone visiting a Dots Space location.

Social Distancing

Floor markers are located in the lobbies, kitchen, and open spaces. People are required to follow social distancing guidelines and keep a distance of at least six feet from other members and staff inside or outside the spaces or while queuing. No gatherings of more than 10 people around the space, and/or within six feet of one another will be permitted.

Space Sanitation

Dots Space has increased cleaning and disinfecting of all high touch surfaces around the spaces according to CDC standards (tables, doorknobs, handles, light switches, countertops, desks, fridges, keyboards, printers, sinks, toilets, faucets, etc.). In addition, Dots Space has increased routine cleaning and disinfecting of conference rooms, brainstorm rooms, and phone booths.

Touch-free hand sanitizing gel dispensers have been installed in lobbies, entrances, hallways, and kitchens.

Signage

Digital signage has been installed in lobbies and kitchens with COVID-19 hygiene guidelines. Awareness posters in and around the space (bathrooms, lobbies, and common spaces) have been hung as a constant reminder for social distancing and hygiene protocols.

Visual guidance such as floor markers in high traffic areas have been installed to keep social distancing as effective as possible.

Access Control

A touchless access system is now utilized in all Dots Space locations and is accessible via a mobile device.

Airflow

High-efficiency, smart HEPA filters are in use to effectively trap harmful particles such as pollen, premium allergens, bacteria, pet dander, dust, debris, tobacco smoke, and prevent airborne viruses and cross-contamination between open areas and offices.

Air is consistently recirculated and filtered as, according to experts, a combination of lower temperatures and higher humidity limits the spread of the virus. Based on this research, Dots Space has adjusted their indoor climate controls accordingly.

Kitchen

- One-touch solutions in the kitchen.
- Disposable cups and silverware.
- Single-use condiments.
- Discontinuation of small snacks and fruit salads. Replaced with whole fruits and prepackaged/individual snacks.
- Complimentary immunity boosters (orange juice, turmeric, and ginger), vitamins and minerals have been provided.
- Sanitization of mugs and glasses in the dishwasher.
- On-demand face masks, gloves, and sanitizing wipes available throughout each location.

Bathrooms

- Regular cleaning and disinfecting of bathrooms throughout the day.
- · Disinfectants in all bathrooms.
- Touchless, sensor powered lights.
- New and updated non-porous bathroom floors in Culver City.

Common Spaces

- Reduced capacity by 50%.
- Distanced/staggered seating in open spaces and meeting/conference rooms.
- Repurposed outdoor and indoor event spaces into escape labs, co-working areas, and outdoor work areas.
- Elevators limited to 2 people maximum.
- Enforced queues and markings in kitchen, bathrooms, printing rooms and at valet stations.


